Dear PNBC Family,

I greet you with Jesus' joy as we prepare for PNBC's 65th Annual Session being held in Washington, DC at the Omni Shoreham Hotel 2500 Calvert Street, NW Washington, DC. This year's session will kick off on Sunday, July 19 @ 6:00PM with an anniversary gala. This session will be a 3-day power packed event with new Congress classes, exciting new initiatives and departmental meetings to encourage, train and inspire.

This is a voting year, so if you have not completed your 2025 membership, your church will not be eligible to vote. The annual session church registration is \$420 [pre-registration] and \$425 [after June 15]. All persons 21 and over MUST pay the Individual (Messenger) Registration Fee of \$105 [pre-registration] and \$115 [on site] in addition to Congress and departmental fees which will remain the same. Youth registration [up to age 20] is \$60 and all youth MUST register to participate in the Youth Department. Any forms received after **June 15, 2026**, will be treated as onsite registration. Processing fees are included in the fees.

We are urging all members, especially delegates to pre-register. This will help ensure the printing of the badges and preparing the listing for electronic voting. Enclosed with this letter is the:

Youth Department Participation Permission Form and Liability Release

I hereby grant my child, _____,

permission to attend and participate in all activities and ventures offered by and/or through the Progressive National Baptist Convention, Inc. (a District of Columbia religious nonprofit organization) and its Youth Department, (hereinafter referred to as "PNBC") beginning on _____, and continuing in full force and effect until this Release is revoked by me in writing and said writing is delivered to PNBC. I agree that the attendance of my child at any conference, or PNBC activity constitutes my agreement with and acceptance to the terms of this Release. I agree that my child's picture or likeness may be included in any photographs or videos taken at any such event.

I accept full responsibility for my child's actions, and I hereby indemnify and hold harmless the PNBC, its local churches, approved ministries, agents, employees and assigns, against any and all loss or damage arising from any and all accidents or injuries caused by my child, whether accidentally or willfully, to: (i) property owned by the PNBC, or any Department or church member within the PNBC; (ii) property of those acting as employees, agents or assigns (including, without limitation, volunteers and event staff), of the PNBC, or any of its departments, local churches, or approved ministries; and (iii) personal injuries or death suffered by any employee, agent, volunteer or staff member of the PNBC or any department or affiliated church approved within the PNBC.

I further accept full responsibility for my child's safety and I hereby release, hold harmless, and agree to indemnify and defend PNBC, its agents employees and assigns, including, without limitation, volunteers and event staff, from and against any and all damages arising out of, relating to or resulting from my child's participation in any PNBC-approved or sponsored activity, except to the extent wholly caused by the gross negligence or intentional misconduct of any such volunteer(s) or event staff.

In the event of injury to or illness of my child while engaged in an PNBC-approved or sponsored event, I hereby expressly grant to the PNBC, its agents, employees and assigns, permission to seek such medical care (including emergency treatment) as any of such persons reasonably believed is needed, based on their good faith assessment of all attendant facts and circumstances, and I hereby agree to indemnify and hold harmless the Progressive National Baptist Convention, together with all of its affiliated churches, approved ministries, agents, employees and assigns, from all expenses incurred in obtaining medical treatment for my child.
